Kirk and Kathie let Kathy know that they were not contacted back about helping with the platform this last spring and there is no evidence it was put up. We tabled a discussion about our constructing our own for Boardman Lake next spring with member Nate Crane's advice.

Kathie suggested a Bird Alert email to our members to remind them to get summer strawberries for the farm that allowed birders access to view the Pink Footed Goose. Kirk provided Kathie with the information for the Berry Flats Fruit Farms and Kathy will send the email.

Bird Books Donation to the Traverse Area District Library

Kirk and Kathy decided it would be prudent to double check the TADL library inventory for the title of the books we are contemplating donating, so we don't duplicate what they already have. We'll look to provide a donation possibly this September.

Member email bounce back

Kathie let the board know that after double checking that an email of a member was correctly input in our group email (Bird Alert), an email was still getting bounced back. Kirk suggested that there was some type of filter on the members end of things within their email settings. (Kathie contacted the member after this suggestion, and the member was able to adjust their settings and are now receiving Bird Alerts)

Logo Patches / Hats

Kathie wanted to know the board's opinion on whether to proceed with the proposal she received from Alfie Embroidery for patches and hats with our chickadee logo. The would be sublimated, not embroidered, due to the complicated detail of our logo. Kathy said that she thought that there was already at least a small inventory of our logo on patches that were actually embroidered. She will attempt to locate them for us to see. In the meantime, Kathie will:

Provide the board with an update to the bottom line of a minimum order.

Provide the lead time for a minimum order.

Purple Martin House Check (Botanic Gardens)

Kathie contacted the Botanic Gardens to see about mowing the grass to the birdhouse so that we could do our checks. This was done by Kurt Schmidt, one of the managers and founders of the Botanic Gardens. Kathie cleaned out the house and it's ready for a possible second brood of birds.

Christmas Cards/List Update

We will add Berry Flats Fruit Farms to our Christmas Card list. Kathie mentioned trying to find Christmas Cards that benefit a birding cause.

Venmo Snag

Kathie let the board know that a successful payment/membership sign up happened earlier in the week with PayPal. However, in trying to create an account with Venmo for membership convenience, there was an issue in that Kathie's phone number is already linked to her personal Venmo account and cannot be used for a business account. The

only work around, she thought, was to get a cheaper phone just for GT Audubon Club use. This seemed a bit more complicated than we feel we need to tackle at this time.

Master Username / Password List

It was decided that the Treasurer and the President would have access to a complete list of complied access information.

Kathie has a working list and will submit to Kathy, as president, when complete. We'll add our Boardman River Nature Center cabinet combination to this list as well as our Instagram account information.

We still need to work around the issues with our club Facebook page being tied to a previous board member's personal account.

Non-Profit Interest Update

Kathie let the board know that she learned a lot in the 'So You Want To Start a Non-Profit' class. She let the board know that we are on track in most areas concerning steps to becoming a non-profit. Unfortunately, there are two major hurdles to overcome. One is that we are considerably late in applying for non-profit status after becoming a formal social club with an EIN number. The second is that we need to create and submit an Articles of Corporation form. The form is long and complicated and will take considerable time to complete and many decisions have to be made in doing so. It has been suggested that we ensure that our club mission is a charitable one and we demonstrate this in order to be approved as a 501-C3 charitable organization.
